District to Host Community Input Meetings on Parks in Lang Ranch and Neighboring Communities

Since the Master Plan for the Lang Ranch Community Park has been abandoned by the Conejo Recreation and Park District, the Board of Directors has asked the District staff to seek input from residents interested in parks and recreational amenities in the District's planning zone 2. (The District's planning zone 2 generally includes properties east of the 23 freeway and north of Hillcrest Drive.)

District Parks within zone 2 include:

Old Meadows Park
Conejo Creek North and South Park
Lang Ranch Neighborhood Park
Lang Ranch Community Park
Oakbrook Neighborhood Park
Sunset Hills Park

(This list does not include open space and special facilities such as the Oakbrook Chumash Interpretive Center).

District staff plan to host 4 brainstorming meetings open to anyone to receive input, ideas, suggestions and concerns regarding potential future recreational uses for the Lang Ranch Community Park property. Residents will also be able to provide input regarding the other parks in their area.

Information from these meetings will be compiled for the Board of Directors' consideration at a subsequent CRPD Board meeting.

Wear comfortable shoes and hiking clothing and be prepared to walk approximate 2.5 miles round trip with approximately 200 foot elevation gain.
